Ruth encouraged the members to attend the input sessions.

## LPC Advocacy Committee 2015 - 2016 Goals

### **Goal 1:**

Host Annual Young Children's Issues Forum (YCIF) – March 2016

#### **Outcomes:**

- ❖ Increased community awareness of children's issues
- ❖ Increased attendee knowledge of resources and tools available for advocacy (*participant packets, resource fair, other handouts, and table discussions*)
- ❖ Affirm shared understanding of the importance of Early Childhood Education for children's success in school and life in general-*Common Agenda*
- ❖ Acknowledge shared responsibility for children's education by business leaders, elected officials, community leaders, families, and educators  
*\*Evaluation form will be expanded to include additional data facts and questions that document the benefit of participation and knowledge gained through participation in the forum.*
- ❖ Engage elected officials, business leaders, and community leaders in supporting families and educators in finding solutions for: accessible child care facilities, increasing State Reimbursement Rates (SRR) for Title V centers, **and increase compensation and retention of a qualified workforce.**

### **Goal 2:**

Develop compelling messages **in collaboration with** civic and business leaders in support of early childhood education **including improved compensation and professional development.**

#### **Outcomes:**

- ❖ Shared and common vocabulary of key terms, such as quality and State Reimbursement Rate (SRR).
- ❖ Active social media campaign/training to help Child Development Centers present themselves (website, blog, stickers, banner, texting campaign, etc)
- ❖ New relationships and connections with business leaders in our region.

### **Goal 3:**

To develop and maintain a strategic data plan to track short-term and long-term impact of child care issues, including facilities, **compensation** and reimbursement rates in Contra Costa County.

#### **Outcomes:**

- ❖ Local template for data collection
- ❖ Increased awareness of impact of budget cuts at County level
- ❖ Key message consistently delivered by all members of the community (parents, educators, administrators, policy makers, etc)
- ❖ Compensation survey in collaboration with Bay Area Local Planning Councils

## 2015 Early learning bills

- AB 47** (McCarty D) **State preschool program.**  
**Status:** 10/9/2015-Vetoed by the Governor  
**Summary:** Would require, on or before June 30, 2018, all eligible children who are not enrolled in transitional kindergarten to have access to the state preschool program the year before they enter kindergarten, if their parents wish to enroll them, contingent upon the appropriation of sufficient funding in the annual Budget Act for this purpose.
- AB 74** (Calderon D) **Child care facilities: regulatory visits.**  
**Status:** 9/30/2015-Vetoed by the Governor  
**Summary:** Would revise the provisions requiring the State Department of Social Services to conduct annual unannounced inspections of a child day care center or family day care home by instead requiring the department to conduct annual unannounced inspections of no less than 20% of those centers or homes on and after January 1, 2018, and until January 1, 2019. The bill would also require, on and after January 1, 2018, and until January 1, 2019, the department to inspect each center or home at least every 2 years.
- AB 271** (Obernolte R) **Child care: alternative payment programs and contractors: electronic records: digital signatures.**  
**Status:** 10/4/2015-Chaptered by Secretary of State - Chapter 476, Statutes of 2015.  
**Summary:** Current law authorizes alternative payment programs and providers and other contractors providing child care development services to maintain records in electronic format if the original documents were created in electronic format, including, but not limited to, child immunization records. This bill would authorize contractors and alternative payment programs and providers to maintain any records electronically, as provided, regardless of whether the original documents were created in electronic format.
- AB 762** (Mullin D) **Day care centers: toddler programs.**  
**Status:** 9/30/2015-Chaptered by Secretary of State - Chapter 373, Statutes of 2015.  
**Summary:** Would require a day care center with a toddler program to extend the toddler program to serve children between 18 months and 3 years of age, and would make conforming changes relating to the guidelines and procedures the State Department of Social Services is required to develop. By changing the definition of an existing crime, the bill would impose a state-mandated program. This bill contains other related provisions and other existing laws.
- AB 833** (Bonta D) **Child care and development services: individualized county child care subsidy plan: County of Alameda.**  
**Status:** 10/7/2015-Chaptered by Secretary of State - Chapter 563, Statutes of 2015.  
**Summary:** Would authorize, until January 1, 2021, the County of Alameda to develop an individualized county child care subsidy plan, as specified. The bill would require the plan to be submitted to the local planning council and the Alameda County Board of Supervisors for approval, as specified. The bill would require the Early Education and Support Division of the State Department of Education to review and approve or disapprove the plan and any subsequent modifications to the plan.
- AB 982** (Eggman D) **Child care and development: eligibility: homeless children.**  
**Status:** 10/7/2015-Chaptered by Secretary of State - Chapter 567, Statutes of 2015.  
**Summary:** Current law requires families to meet certain requirements in order to be eligible for subsidized child development services, including that the family needs child care services because the child is identified by a legal, medical, or social services agency, or emergency shelter as being a recipient of a protective service or being neglected, abused, or exploited, as provided. This bill would expand the list of entities that can identify a child in need to include a local educational agency liaison for homeless children and youths, a Head Start program, or a transitional shelter.
- AB 1207** (Lopez D) **Mandated child abuse reporting: child day care personnel: training.**  
**Status:** 10/1/2015-Chaptered by Secretary of State - Chapter 414, Statutes of 2015.

**Summary:** Would, beginning January 1, 2018, require the State Department of Social Services to develop and disseminate information to providers, administrators, and employees of licensed child day care facilities regarding detecting and reporting child abuse, and to provide training including statewide guidance on the responsibilities of those persons as mandated reporters, as provided. Beginning January 1, 2018, the bill would require those persons, as a condition of licensure, to complete that training provided by the department, as specified.

**SB 277 (Pan D) Public health: vaccinations.**

**Status:** 6/30/2015-Chaptered by Secretary of State - Chapter No. 35

**Summary:** Would eliminate the exemption from current specified immunization requirements based upon personal beliefs, but would allow exemption from future immunization requirements deemed appropriate by the State Department of Public Health for either medical reasons or personal beliefs.

**SB 311 (Beall D) Child Care and Development Services Act: preschool: Alum Rock Union Elementary School District: pilot project.**

**Status:** 8/27/2015-August 27 hearing: Held in committee and under submission.

**Summary:** Would authorize the Alum Rock Union Elementary School District, located in the County of Santa Clara, and a preschool program, as defined, as a pilot project until June 30, 2021, to develop and implement an individualized eligibility part-day preschool plan for children residing in the school district for purposes of attending a preschool program in the school district. The bill would require the school district and the preschool program to consult with the Santa Clara County Office of Education and First 5 Santa Clara County in developing the plan.

**SB 548 (De León D) Child care: family child care providers: orientation training.**

**Status:** 10/11/2015-Vetoed by the Governor

**Summary:** Would require the State Department of Education to ensure that all family child care providers, as defined, attend an in-person orientation training, as provided. The bill would require the orientation training to include at least 4 hours of instruction and include specified information, including minimum health and safety standards, as provided. The bill would authorize the Superintendent to adopt rules and regulations regarding the orientation training. This bill contains other related provisions.

**SB 792 (Mendoza D) Day care facilities: immunizations: exemptions.**

**Status:** 10/11/2015-Chaptered by Secretary of State - Chapter 807, Statutes of 2015.

**Summary:** Would, commencing September 1, 2016, prohibit a person from being employed or volunteering at a day care center or a family day care home if he or she has not been immunized against influenza, pertussis, and measles. The bill would specify circumstances under which a person would be exempt from the immunization requirement, based on medical safety, current immunity, declining the influenza vaccination, or the date upon which he or she was hired, as specified.
